INCREASE OF INTEREST IN ASSOCIATED COMPANY

Pursuant to Rule 704(17)(d) of the SGX-ST Listing Manual, the Board of Directors of Chuan Hup Holdings Limited (the "Company") wishes to announce that the Company's interest in its associated company, CH Offshore Ltd. ("CHO"), has increased to 173,941,026 shares or 24.67% of CHO's issued capital (705,090,514 shares).

The increase in its shareholding was pursuant to open market purchases by the Company of an aggregate of 6,388,000 CHO shares on 19 January 2015 at the average price of S\$0.503474 per share.

The consideration payable by the Company will be satisfied in cash and funded by internal resources.

The acquisition is not expected to have a material financial impact on the net tangible assets per share and earnings per share of the Company for the financial year ending 30 June 2015.
