The entire shareholding of Qing Shan is currently held by TMF Trustees Singapore Limited as trustee of the trust constituted by Mr Peh Kwee Chim ("Trust").

Mr Peh Kwee Chim is a director of KXG and is also the settlor of the Trust, and is therefore deemed, pursuant to Section 4 of the Securities and Futures Act, Chapter 289 of Singapore and Section 7 of the Companies Act, Chapter 50 of Singapore, to have an interest in the 478,264,490 ordinary voting shares of the Listed Issuer held by KXG.
